### **COMPLETION OF SHARE PURCHASE PLAN AND PLACEMENT**

The Directors are pleased to advise that the Equus Mining Share Purchase Plan ('SPP'), as announced on 21 July 2014, have been Completed with an encouraging level of participation resulting in the allotment of 52,100,000 new fully paid ordinary shares totalling \$521,000.

In addition, the Company has placed, in accordance with the Company's 15% capacity pursuant to ASX Listing Rule 7.1, a further 22,500,000 shares. The shares were issued at 1 cent, the same price as the shares issued under the SPP, raising an additional \$225,000.


