The Company intends to continue with its drilling campaign during the June quarter and downsize activities in accordance with available cash. The effect of these measures will be to provide sufficient funds to continue operations for the next two quarters.

Answer:	
The Company intends to raise further capital during the quarter ending June to continue with its drilling program at Cerro Bayo beyond the September quarter. The Company believes that the capital will be available due to the advanced and positive status of the current drilling program and resource evaluation at Cerro Bayo.
