	<p>Answer:</p> <p>Following the acquisition of Compañía Minera Cerro Bayo, the Company provided Cerro Bayo with working capital to operate and fund the initial timing difference between revenue and payments and for non-recurring expenses. The Company believes that this timing difference will improve in the coming quarters from positive net cash flow at Cerro Bayo.</p>

	<p>Answer:</p> <p>The Company is aware of the Group's cash position. However, if required further cash will be raised in the future.</p>
