- ▶ The Company is continuing to actively review other investment opportunities.
- ▶ The Company negotiated an amendment to the Sale Agreement with Andean Silver Limited (ASX:ASL) to allow for an early settlement of the final payment due to Equus.
- ▶ During October Equus received A\$750,000 in final settlement with ASL

MARCH 2025 QUARTER – PLANNED ACTIVITY

- ▶ With its cash reserve to execute a transaction, Equus Mining is actively reviewing investment opportunities.

CORPORATE

- ▶ At 31 December 2024, Equus had cash of \$535,000
- ▶ There was no expenditure on exploration
- ▶ During the December quarter, the aggregate payments to related parties of the entity and their associates totalled \$113,000, this included amounts outstanding from the previous financial year.
- ▶ During the December quarter the directors' focus was on reviewing investment opportunities for Equus.
