#### Tim Banfield – Head of Distribution

Tim will oversee marketing and business development for WFM.

Tim began his career in 2001 with OM Strategic Investments in Sydney which was acquired by London listed investment manager Man Group Plc. During 10 years at Man Investments Australia, Tim was appointed to Head of Retail Marketing and Director of the company.
