Prodigy Investment Partners Announces New Partnership With Equus Point Capital

Prodigy Investment Partners Limited (**Prodigy**), a joint venture between Euroz Limited (**Euroz**) (ASX Code: EZL) and Mr Steve Tucker, today announced details of its third boutique funds management partnership, Equus Point Capital.

Equus Point Capital (**Equus**) is a market neutral strategy focusing on Australian equities. We believe it is the first of its kind in the Australian market. Equus will target a return of 7.5%-12.5% p.a. above benchmark using a systematic approach to harvest both positive and negative momentum in a risk controlled environment. The Equus team have been successfully managing this specific strategy for the last 18 months.

Equus will be led by Co-Founders and Portfolio Managers Rob Stewart and Toby Masters. Rob has over 25 years of investment management experience in enhanced index and momentum based investing including Portfolio Manager at Challenger Limited and Head of Index Funds and Asset Allocation at Colonial First State Global Asset Management. Toby brings with him extensive experience in proprietary trading and short term momentum investing including as Director of Equity Derivatives at Credit Suisse and was most recently a partner in a private hedge fund, Pittwater Capital.

Prodigy will bring this new strategy to the Australian market in the fourth quarter of 2018 and are targeting \$500m capacity. Prodigy has already established investment partnerships with top performing emerging company's manager, Flinders Investment Partners and rapidly growing alternative manager, Dalton Street Capital.

Founding Partner of Equus Point Capital, Mr Rob Stewart said "We are delighted to be partnering with Prodigy and look forward to establishing a strong presence in the alternative investment market with our market neutral strategy. Prodigy brings an innovative business model, infrastructure, capital and proven distribution capabilities which will provide a strong platform for the Equus Point Capital business."
