Great Southern Mining Limited (ASX:GSN) (**GSN** or the **Company**) is pleased to announce it has completed the transaction to acquire a 100% interest in a tenement package (being exploration licences E38/2829, E38/2442, E38/2587 and E38/2856) from Central Australian Rare Earths Pty Ltd, as announced on 3rd September 2018.

As part consideration for the acquisition of the tenement package the Company has issued 1,000,000 fully paid shares (at a deemed issue price of \$0.045 per share) to Central Australian Rare Earths Pty Ltd. The shares will be subject to voluntary escrow until 30 December 2018 (500,000 shares) and 30 June 2019 (500,000 shares).
