APPENDIX 2A AND CLEANSING NOTICE

Great Southern Mining (ASX: GSN or the “Company”) is pleased to announce that a further 5,000,000 fully paid ordinary shares have been issued on the early exercise of unlisted options by unrelated parties. The unlisted options were exercisable at any time until 4 September 2022 at an exercise price of \$0.06 per option. The amount raised on this exercise is \$300,000 which along with highly successful capital raising in May 2020 of \$3.15m, adds to the Company’s already strong cash position.
