Capital Raise Completes Raising \$3.3 Million Funding Production of DSO Iron Ore C4 Project

GWR Group Limited (**ASX:GWR**) (“**GWR Group**” or “the **Company**”) is pleased to announce that it has allotted and issued 18,333,333 fully paid ordinary shares in the Company (Shares) at an issue price of \$0.18 per Share (Placement) to raise \$3.3 million (before costs).

The Placement was made to qualified, institutional and professional investors and included 1 free carried option for every 4 placement shares allotted. GTT Ventures Pty Ltd acted as Lead Manager to the placement.

Placement Details

The Placement was completed pursuant to the Company’s issue capacities under Listing Rule 7.1 and 7.1A. A total of 18,333,333 Shares were issued pursuant to Listing Rule 7.1A and 4,583,333 options were issued under Listing Rule 7.1. Further details of the Placement are included in the Appendix 3B lodged with ASX on Thursday 1 October 2020.

Under the terms of their mandate GTT Ventures Pty Ltd will receive a 6% fee and 8,250,000 options.

The Placement and Lead Manager options are exercisable by payment of \$0.40 each on or before 1 October 2022. The Company intends on making application to ASX for the quotation of the options.
