## Notice under Section 708A(5)(e) of the Corporations Act

Medallion Metals Limited (the **Company**) gives this notice under section 708A(5)(e) of the *Corporations Act 2001 (Cth)* (the Act).

The Company advises that it has issued 225,000 ordinary shares (**Shares**) following the exercise of unquoted incentive options (**Incentive Options**). The Incentive Options were issued pursuant to the Company's Incentive Option Plan, under which options may be issued to directors and employees of the Company from time to time.
