# First blast completed at Blackjack as NMR progresses toward gold production in July

## **Highlights:**

- Drill and blast commenced at Blackjack Gold Project, Qld with the first blast fired at the Southern Starter
   Pit on 26 June 2025.
- 128 holes drilled and 6,788kg of explosives used to move ~27,700 tonnes of material.
- Material delivery to ROM pad expected in early July 2025 with operations progressing toward first gold pour by July 2025.
- Plant refurbishment nearing completion, with pre-commissioning sign-offs underway across all areas.
- Dry commissioning completed for Area 01 (crushing and screening); progressing in Area 02 (grinding).
- Tailings Storage Facility (TSF) upstream embankment lift to crest height completed; piping and spigot installations scheduled for completion next week.

Native Mineral Resources Holdings Limited (ASX: NMR) ("Native Mineral Resources" or the "Company") is pleased to announce completion of its first production blast at the Blackjack Gold Project in northern Queensland on 26 June 2025. This milestone marks the transition from development to material delivery to ROM pad as the Company progresses towards first gold production in July 2025.

**NMR Managing Director Blake Cannavo said:** "The commencement of drill and blast at Blackjack marks a major milestone for Native Mineral Resources as we transition from planning into full-scale operational execution. This activity is the first physical step in unlocking the value of our Charters Towers assets and sets the stage for plant commissioning, and ultimately first gold production. I'm proud of the team's disciplined approach and the momentum we've maintained as we bring this historic project back to life."

## Key progress since last update

#### **Process Plant Refurbishment**

Refurbishment is in the final close-out phase with all major areas undergoing pre-commissioning. Dry commissioning of Area 01 (Crushing & Screening) has been completed, with Area 02 (Grinding) due for completion in the coming days. Wet commissioning is on track for July. Non-critical punch list items will follow.

Final commissioning of the gold room and laboratory is scheduled for early July. A complete electrical reticulation model has been developed using PTW software and redrafted SLDs are being prepared to support the upcoming Ergon CPR application. Network analysis and engineering submission are progressing.

#### **Drilling & Mining Readiness**

All mining equipment has been delivered. Mining One is finalising the starter pit design and mine scheduling, due in early July. Haulage road construction is underway, with material to the ROM pad expected in early July. The new pit cutback design will be submitted as part of the EA major amendment process.

### Tailings Storage Facility (TSF)

All pre-discharge TSF works are complete. Upstream embankment lifts on both the eastern and western walls have been constructed. Piping and spigot installations are underway through the temporary bundwall, aligning with commissioning readiness. The TSF lift design package will be issued in early July as part of the Environmental Authority (EA) major amendment submission.
