**DIVESTITURE AND CHINA MOBILE DEBT UPDATES**

**Orcoda Limited (ASX:ODA) ('Orcoda or the Company')** On 13 August 2018, the Company announced that it had signed a non-binding agreement for the sale of Smartrans HK Limited and its Chinese subsidiary.

Further to the August announcement, the Company today announces that it has entered into a binding option agreement with OpenDNA Limited (ASX: OPN), under which the Company will sell Orcoda's interest in its Hong Kong entity, Smartrans (HK) Limited and its wholly foreign-owned subsidiary incorporated in Beijing, SmartTrans Technology (Beijing) Company Limited, which has arrangements with a Beijing incorporated Chinese owned entity.

Under the terms of the agreement, OpenDNA has a 90-day exclusive option to acquire Smartrans (HK) Limited. The value of the option is A\$50,000 followed by a further acquisition payment of A\$150,000 should OpenDNA elect to exercise its option.

The deal does not include the RMB20M (A\$4M) China Mobile debt receivable, which is currently the subject of collection litigation, which has been heard twice in the Nanjing courts. A follow up hearing is scheduled for mid-October.

Orcoda Managing Director Brendan Mason said: "The decision to sell our Hong Kong and China business followed a comprehensive analysis of Orcoda's entire operations, as announced on 16 July 2018. The divestment will enable us to focus our attention on driving improvements in our Australian based logistics group. The assets seem to be a good fit for OpenDNA."
