# Bonanza Gold Grades Intersected in Drilling at the Alice River Gold Project

- High-grade gold zones with exceptional continuity intersected in drilling, including zones containing bonanza gold grades:
  - o 24m @ 8.0g/t Au (from 168m) incl. 1.9m @ 87.0g/t Au (ARDH051)
  - o 4m @ 10.3g/t Au (from 563m) incl. 1m @ 32.8g/t Au (ARDH050)
- The successful step-out drilling extends high-grade gold mineralisation a further
   120m vertically to over 520m depth (remains open at depth)
- ARDH050 & ARDH051 are ~160m north of the spectacular intersection of a 16.4m interval of visible gold¹ recently reported in ARDH061 (results pending)
- Central Target now contains multiple south-plunging high-grade zones identified from drilling along 400m (to date) of the known 1.5km strike of the F1a zone (remains open along strike and at depth)
- Step-out and definition drilling continues on the F1a zone with assay results pending for 13 drill holes, all of which intersected strong veining and alteration

**Pacgold Managing Director Tony Schreck said**: "Bonanza intersections of 1.9m @ 87.0g/t Au represent the highest gold grades defined by Pacgold to date on the F1a zone and this particular intersection forms part of a continuous high-grade zone which extends from surface to a depth of 520m, remaining open at depth. Based on the similarities with the Donlin gold model (Tier-1 gold deposit in Alaska), we expect the high-grade zones to continue to extend at depth over a significant vertical distance. This has the potential to contribute materially towards a JORC Resource.

Multiple high-grade zones (or shoots) are now being revealed along a 400m strike length where wide-spaced drilling has so far been completed. The F1a zone is defined over 1.5km which forms a portion of the priority 7km corridor encompassing the Central, Southern and Northern Targets.

Our drilling strategy to date has been focused on the Central Target, where we have achieved exceptional results that provide an excellent opportunity to potentially define a material-sized JORC Resource."

Pacgold Limited (ASX: PGO) ('Pacgold' or the 'Company') is pleased to provide an update of drilling assay results from the Company's Alice River Gold Project. To date, 26 drill holes (diamond ('DD') and reverse circulation ('RC')) have been completed on the Central Target in the current programme, with assay results pending for 13 drill holes targeting the F1a zone. The current drilling programme of 17,500m is ~60% advanced with 5,472m RC and 5,300m DD completed. Approximately 80% of the drill programme will focus on the F1a zone (Central Target) with the remaining 20% to investigate other areas within the Southern and Northern Targets.

### F1a Zone Drilling Update

Assay results for five drill holes are reported here - ARDH045, ARDH047, ARDH050, ARDH051 and ARDH052.

As anticipated, **bonanza-grade gold was intersected in ARDH051** with the occurrence of coarse visible gold in the drill core. ARDH051 targeted the up-plunge projection of the drill intersection of 40m @ 3.0g/t Au incl. 6m @ 17.5 g/t Au (incl. 1m @ 79.1g/t Au which contained visible gold) in ARDH027<sup>2</sup>.

ARDH051 intersected the mineralised zone approximately 60m up-plunge from ARDH027, returning a broad zone containing high-grade gold:

24m @ 8.0g/t Au from 168m
 incl. 1.9m @ 87.0g/t Au from 168m
 incl. 1.1m @ 136.5g/t Au from 168.8m




Figure 1: Drill Section insert showing ARDH051; location shown in Figure 2




Figure 2: Drill Section showing location of ARDH050 and ARDH051, with high-grade gold extending vertically over 520m




Figure 3: Zoom of Central Target long section along the F1a zone shown in Figure 5




Figure 4: Long section through the Central Target showing the F1a target zone. Location of the long section is shown in Figure 5





Figure 5: Plan showing the drill hole locations on the IP geophysics resistivity image and showing the F1a zone

The location of ARDH051 is displayed on Figures 1 and 2 (drill cross sections), Figures 3 and 4 (long sections) and Figure 5 (surface drill plan).

The assay results for ARDH051 define excellent continuity of bonanzagrade gold zones over at least 60m distance between ARDH027 and ARDH051. The gold intersections in these holes form part of a larger, continuous, high-grade gold zone containing intersections of 10g/t Au or greater and extending from the base of the shallow historical open pit to a depth of 520m below surface (drill hole ADRH050).

**Drill hole ARDH050** represents the deepest hole completed on the project and intersected high-grade gold:

4m @ 10.3g/t Au from 571m
 incl. 1m @ 32.8g/t Au from 573m

**Step-out drill hole ARDH045** returned high-grade results including:

4.7m @ 5.8g/t Au from 348m
 incl. 1m @ 10.6g/t Au from 349m

ARDH045 represents a significant step-out of 200m targeting the down-plunge projection of the drill intersection of 40m @ 3.0g/t Au incl. 6m @ 17.5 g/t Au in ARDH027<sup>3</sup> and is located 80m to the south of drillhole ARDH040 and approximately 330m below surface. This drill hole provides excellent early support for the steep southern plunge geometry on the gold system. Refer to Figure 4 (Long section).

Definition drilling is being planned to close up the current wide-spaced drill density and provide data for ongoing refinement of the geological and structural model.

**Step-out drill holes ARDH047 and ARDH052** intersected broad zones of veining and alteration with associated gold mineralisation and are interpreted to represent a 'halo' to nearby high-grade mineralisation to the immediate south and potentially to the north. A summary of drill results is presented in Table 2.

The recently reported spectacular zone of visible gold in ARDH061<sup>4</sup> (over 200 individual visible gold occurrences) within a 16.4m downhole interval is located 160m south of ARDH050 & ARDH051 (latest results are presented in this release). Assay results for ARDH061 are pending and the location of the hole is displayed on Figures 3 and 4 (long sections) and Figure 5 (drill surface plan).

#### **Exploration Model**

The application of the Donlin gold model (Tier-1 gold deposit in Alaska) to the project is proving to be very successful. An important aspect of this model is the potential for the high-grade zones to have significant vertical extent, as demonstrated at Donlin. At Alice River, the high-grade zones are now defined over 520m of vertical extent and are open at depth.

The high-grade gold mineralisation observed at the F1a zone is associated with zones of intense multi-phase, hydrothermal quartz veining and brecciation. The current drilling on the Central Target continues to provide strong indications that the F1a zone represents the upper levels of a large-scale, high-grade gold system. Pacgold has identified two primary controlling (north-south trending) structures on the Central Target, being the F1a and the F1b zones (refer to Figure 5). The highest gold grades intersected in drilling occur where broad, north-west trending, 'linking' vein sets intersect the F1a and F1b zones. Drilling to date by Pacgold has concentrated on a 400m section of strike on the 1.5km-long F1a zone where multiple high-grade plunging zones are currently being defined. Repetitions of this structural setting have been identified along the northern extent of the F1a zone and some initial scout drilling has been completed, aimed at locating the intersection of the north-west trending veining corridor with the F1b which is completely concealed by shallow sand cover (results pending). Scout drilling has also been completed on the F1b zone where Pacgold's drilling last year returned 7m @ 3.1g/t Au incl. 2m @ 9.8g/t Au (ARDH031)<sup>5</sup>.

In simpler terms, 'bends' along the main structure are interpreted to potentially represent dilation zones which can focus gold mineralisation. These 'bends' can be seen in the IP geophysics (mapped as resistivity lows), with the best example being at the Central Target (Figure 5).

It is interpreted that the gross structural setting at the Central Target which controls the distribution of the high-grade gold zones has many similarities to that observed in several large gold deposits, including Fosterville 4.4Moz (Australia) and Waihi 4Moz (New Zealand).




Figure 6: Left - Alice River Gold Project regional setting. Right – Zoom of 7km long priority targets

On a regional scale, the structural model for the high-grade mineralisation is being applied to the Southern Target to generate priority targets within the broad gold system ahead of a drilling programme planned for Nov 2022. Further IP geophysics is also planned for the Northern Target ahead of drilling planned for Nov 2022. Wide-spaced IP geophysics is also planned to step out along the main Alice River Shear zone to the north-west and to the south-west, to identify the structure over 10km of potential strike. Pacgold has over 50km of under-explored prospective structure secured under exploration permits (granted EPMs and applications), see Figure 6.

#### **Next Steps**

Two DD rigs plus one RC rig will continue drilling at the project for the next 3 months as part of the current drilling programme, with 80% focus on the Central Target and 20% as part of the Project Pipeline (including Southern and Northern Targets). Drill results for hole ARDH061<sup>6</sup> (which intersected spectacular visible gold), along with several other holes displaying strong alteration and quartz veining are expected to provide strong news flow in the coming weeks.

IP geophysics is planned on the Northern Target and extensions along the Alice River Shear Zone to the north-west and south-west of the current IP coverage. This work is currently scheduled for Oct 2022.




Figure 7: Alice River Gold Project regional setting
