# **ACQUISITION OF STRATEGIC LAND HOLDINGS BODE WELL** FOR MT CHALMERS COPPER DEVELOPMENT STRATEGY

#### HIGHLIGHTS



Contracts executed for two additional freehold landholdings totalling 43-acres adjacent to the Mt Chalmers mine site;



The proposed acquisitions compliment the 126-acre freehold land acquisition and "offgrid" house already purchased;



The freehold land acquisitions expand access for exploration and drilling operations; and



Land acquisition and ongoing resource drilling form part of the Company's integrated strategy of future development of the Mt Chalmers project.

QMines Limited (ASX:QML)(FSE:81V)(QMines or Company) is pleased to announce it has recently entered into two contracts to acquire two additional freehold land packages adjacent to the Company's flagship Mt Chalmers Project. The Company's land holding now covers 169 acres across three freehold properties adjacent to the historic Mt Chalmers mine site. The three freehold properties when coupled with the Mt Chalmers historic mine site now covers 277 acres in total.

Freehold land acquisition is part of the Company's integrated development strategy at the project as it continues drilling operations in and around Mt Chalmers. The Company commenced its land acquisition programme in April 2021 purchasing its first 126 acre parcel of land including an "off grid" site office and accommodation facilities which are now utilised for staff and contractors during operations.

The Company will continue to assess the acquisition of additional freehold land packages in the region as parcels become available and looks forward to updating the market with further developments as and when they occur.

"We are very pleased with these strategic land acquisitions as they assist the Company with its planned copper development strategy. ### **ABOUT OMINES**

OMines Limited (ASX:QML)(FSE:81V) is a Queensland based copper and gold exploration and development company. QMines is seeking to become Australia's first zero carbon copper and gold developer. The Company owns 100% of four advanced projects with a total area of 978km<sup>2</sup>. The Company's flagship project, Mt Chalmers, is located 17km East of Rockhampton. The Project is a high-grade historic mine that produced 1.2Mt @ 3.6g/t Au, 2.0% Cu and 19g/t Ag between 1898-1982. Mt Chalmers has an Inferred Resource (JORC 2012) of 3.9Mt @ 1.15% Cu, 0.81g/t Au and 8.4g/t Aq. 1,2

QMines' objective is to grow its resource base, consolidate assets in the region and assess commercialisation options. The Company has commenced an aggressive exploration program (+30,000m) providing shareholders with significant leverage to a growing resource and exploration success.
