Quarterly Activities Report

MELBOURNE, Australia – Sunrise Energy Metals Limited (**Sunrise Energy Metals** or **Company**) (ASX:SRL and OTC:SREMF) is pleased to provide an update on its activities for the quarter ended 30 September 2023.

Key Developments:

- The Company continues to progress discussions with potential equity funding and offtake partners for the Sunrise Battery Materials Complex ('Sunrise Project')
- As part of recent and ongoing engagement with US auto manufacturers and various US government agencies, the Company is evaluating the option of locating the Sunrise Project's nickel and cobalt refinery in the United States:
 - A US-based refinery will potentially open up opportunities for grant funding pursuant to a number of US Government programs, as well as possible involvement by US-based strategic investors
 - The Company plans to undertake the evaluation in concert with US counterparties, and to that end has engaged a US-based advisor to assist with financing options
- Ongoing work streams to advance the fully integrated Sunrise Project continued with activities focussed on:
 - Advancing work on the electrical transmission line (ETL) work scope
 - Power systems studies that are required as part of the ETL connection agreement have commenced
 - Work continues to advance on the design and planning of civil and overhead services modifications required along the oversized transport route
- Field exploration activities continued to advance during the quarter with a focus on expanding our understanding of the geological potential of our large tenement package in the Macquarie Arc, New South Wales

OCCUPATIONAL HEALTH AND SAFETY & ENVIRONMENTAL PERFORMANCE

The Company had no lost time injuries or reportable environmental incidents recorded during the quarter.

SUNRISE BATTERY MATERIALS COMPLEX

During the quarter, the Company continued to advance the development of the Sunrise Battery Materials Complex. A range of workstreams remain ongoing to progress several value-adding deliverables aimed at minimising Project start time once a financing package is secured and a final investment decision (FID) is made. Key work programs included:

- Advancement of the long-lead electrical transmission line (ETL) work scope.
- A land access licence application over Crown Land lots for the ETL has been submitted.
- Work is continuing with Essential Energy on the electrical network connection agreement process. The planned network connection point is a new substation located 2km north of the existing Transgrid Parkes 132kV substation. The new substation is planned to be constructed to support a new solar farm project (Quorn Park) and other future large connections such as the Parkes Special Activation Precinct. Connecting to this new substation shortens the transmission line by 1.5 km and results in a simplified connection process, involving only one network service provider.
- SRL's technical consultants, GHD, are undertaking the necessary power systems studies that are required as part of the electrical network connection agreement. This work commenced in September and will take approximately 3 months to complete.
- Work is progressing on the design and planning of civil and overhead services modifications
 required along the oversized transport route from Port Pirie to the Project site, with engagement
 with key road and power authorities throughout the month. GHD have been engaged to
 undertake this work, which will extend through to December 2023.
- Planned pump testing of the three newly drilled water bores has been awarded to Watson Drilling and will take place after the summer harvest.

Project Financing

The Company continues to proactively engage with a range of participants in the electric vehicle
 (EV) industry with a view to securing project-level equity funding, in conjunction with offtake,
 to underpin a complete financing package for Sunrise. The partnering process remains ongoing,
 however the targeted timing for completion of any transaction is not possible to forecast.

Sunrise to evaluate US location for nickel-cobalt refinery

Recent feedback from both the auto sector and US Government agencies has focussed on the potential of locating Sunrise's nickel and cobalt refinery in the United States.

The relocation of the refinery to the United States could be undertaken to satisfy eligibility criteria under several US Government funding initiatives focused on critical minerals supply.

The estimated cost of the refinery as forecast in the Sunrise Project Execution Plan, including contingency allowance, is more than US\$200m¹. With a design capacity of up to 25ktpa of nickel (contained in nickel sulphate) and 7ktpa of cobalt (contained in cobalt sulphate), refined production could support the manufacturing of up to approximately 1 million electric vehicles per annum. The refinery has been designed with flexibility to use primary, intermediate (mixed hydroxide precipitate (MHP) or mixed sulphide precipitate (MSP)) and secondary/recycled (black mass) material as feedstock.

EXPLORATION ACTIVITIES

The Company continues to advance activities across its range of exploration assets in New South Wales.

Hunters (ELA6670)

During the quarter the Company applied for a new group 2 (limestone) tenement (ELA6670) located to the south of Trundle. An abundance of what appears to be surface limestone was observed on a first pass field reconnaissance site visit. This tenement is located closer to the Sunrise Project site than the existing third-party limestone source and is located along the approved transport route for the project. Limestone will be a critical processing reagent for the Sunrise Project.

Gleninga South (EL9598)


The Company was granted a new group 2 (limestone) tenement (EL9598) during the quarter. The tenement is located to the west of the Sunrise Project Mining Lease 1770 and is prospective for limestone.

Burra Creek (EL 9317)

A review of historic data for the Burra Creek exploration licence was conducted during the quarter with a subsequent mapping and sampling program taking place within the south-western portion of the tenement targeting geochemical anomalies. Initial geochemistry results (XRF measurements and data analysis) are pending. Initial observations have identified a north to north-east (NNE) trending fault zone (approx. 50m wide) adjacent to the mapped igneous intrusion. It is unclear at

this stage if these features are related, however the fault appears to continue beyond the extremities of the EL9317 tenement boundaries. Given the historical workings in the area, it is possible that this structure may be prospective for tin-silver-gold mineralisation, and further sampling and mapping will be undertaken if geochemical analysis of the samples yields anomalous results.




Sampling of mapped intrusions within the southern part of EL 9317 (Burra Creek)

Meloola (EL8883)

During the period an initial auger drilling plan was developed in anticipation of the acquisition of a suitable rig for future drilling of limestone targets.

Gleninga (EL 8882)

A site visit was undertaken to investigate limestone occurrences on the margins of known existing outcrops. During FY24, fieldwork is scheduled at the Gleninga prospect with the aim of extending the known boundaries of the surface limestone and providing a basis for future auger drilling.


