### NORTH AMERICAN LITHIUM ACHIEVES NEW DAILY PRODUCTION RECORDS

# Québec, Canada

Significant increase in ore mined at NAL operation from mining areas with lower strip ratios and commencement of Phase 3 mining areas with higher ore tonnes than expected.

Record monthly and quarterly spodumene concentrate production, with the quarter up 18% to 40,439 dmt at an average grade of 5.4% Li<sub>2</sub>O. March production of 15,699 dmt was up 13% on prior record.

Adverse weather and tailings line blockages reduced process plant utilisation to 73%, a decrease of 2% compared to the prior quarter.

Lithium recovery for the quarter was 67%, an increase of 5% compared to the prior quarter.

Four marine cargos and one rail cargo of concentrate sold by NAL during the quarter. Of these, one marine cargo and one rail cargo were sold to Piedmont Lithium.

Major capital projects substantially completed at NAL, including the Crushed Ore Dome and Tailings Storage Facility 1. The Crushed Ore Dome started commissioning in April 2024. Lower capital expenditures are expected at NAL moving forward.

Finalisation of Definitive Feasibility Study (DFS) for the Moblan Lithium Project, confirming a post-tax net present value (NPV) of C\$2.2 billion.

# Western Australia, Australia

77-hole aircore drilling program at Tabba Tabba identified high potential pegmatite systems containing caesium and tantalum, across two key drill areas. An orientation ground gravity survey has commenced, with gravity data to assist targeting the pegmatite system and potential lithium rich zones at depth for RC drilling.

# Corporate

Appointment of experienced mining executive, Mr Lucas Dow as independent non-executive director. Mr Dow has joined the Audit and Risk Committee and Nomination and Remuneration Committee.

# **Quarterly Highlights**





# **Management Commentary**

It was another quarter of strong operational performance for Sayona, with concentrate production at NAL increasing 18% Quarter on Quarter (QoQ) to 40,439 dmt. Concentrate sales were up 142% Quarter on Quarter which included some catch up from the December 2023 Quarter and the commencement of rail shipments to Tesla.

Following the completion of an operational review that confirmed on going production ramp-up at NAL, the team continues to optimise mining and production processes, with significant improvements in ore production and future ore availability (ore in sight up 53% Quarter on Quarter). Mill utilisation dipped to 73% (from 75% in the prior quarter) as both adverse weather conditions and blockage issues in the tailings line adversely impacted overall utilisation. Despite these challenges, recovery throughout the quarter continued to improve, successfully meeting the ramp-up target of 67%. In March, the mill performance was particularly strong exceeding the ramp-up recovery target with a recovery rate of 69%.

The Crushed Ore Dome is now complete and commissioning commenced in April. The dome is poised to significantly boost operational reliability during winter, providing an additional 6,000 tonnes storage capacity of crushed ore between the crusher and the mill. The additional storage capacity of crushed ore enables approximately 1.5 days of continuous mill operation without the need for further ore crushing, improving maintenance scheduling for the crushing area. The Tailing Storage Facility 1 has also been completed during the quarter.

The Moblan Definitive Feasibility Study confirmed a net present value for the project of C\$2.2 billion. The challenging market conditions of recent months highlight the importance of developing Tier 1 lithium projects that are strategically located near existing transport corridors with end markets and that have the potential to deliver high grade lithium concentrate at competitive operating costs. Moblan is an exceptional lithium deposit and we will apply Sayona's operational expertise to minimise costs and develop the Project as efficiently as possible.

Exploration activity continued during the March Quarter, with drilling results progressively becoming available at both NAL and Moblan. The results are being compiled for ASX release and may provide the potential for further increases to the existing lithium resources at both projects.

The first drill program at the highly prospective Tabba Tabba lithium tenements in Western Australia has been completed with encouraging results released post quarter. A gravity survey has been completed during April and earthworks prepared for a deeper RC drilling program that will commence shortly.

During the quarter, Sayona appointed Lucas Dow as an additional independent Non-Executive Director which further strengthens our corporate governance. Mr Dow has also joined the Audit and Risk Committee and Nomination and Remuneration Committee.

Sayona has an enviable portfolio of projects and exploration tenements that will generate material value for shareholders and ensure the Company is well positioned in the growing North American lithium market. Amid challenging market conditions, Sayona remains focused on delivering results for shareholders and ensuring the Company is well positioned for the eventual upturn.

# **KEY RESULTS AND ACTIVITIES**

# Safety and Sustainability

#### **Health and Safety**

The Total Recordable Injury Frequency Rate (TRIFR) decreased significantly in the March Quarter, marking the lowest quarterly TRIFR since the restart of operations at North American Lithium. This improvement was driven by a reduction in the number of recordable injuries at NAL, while worked hours at the site remained relatively stable Quarter on Quarter. The NAL mill recorded 1 lost time injury during the quarter.

During the quarter, the Company implemented the critical risks control program, which included training all employees and contractors on risk controls. Reviewed work cards and streamlined toolbox meetings were also implemented during the quarter. The implementation of the critical risks and control program is expected to continue next quarter, in combination with additional planned activities and training for site employees and contractors.

#### **ESG and Community Engagement**

During the quarter, NAL received permitting approval to expand the NAL pit to encompass current Phase 3 mining operations. Additional permitting work progressed during the quarter related to the modification and expansion of waste rock stockpiles.

Engagement with local communities in the Abitibi-Temiscamingue Hub and Eeyou Istchee James Bay Hub continued during the quarter, which included the regular quarterly committee meetings covering matters specific to the NAL operation and Moblan project respectively.

Negotiations continued with the Abitibiwinni and Lac Simon communities with a view to reaching a mutually beneficial Impact and Benefit Agreement. Meetings were also held with Cree communities to discuss the 2024 drilling campaign in the Eeyou Istchee James Bay Hub.

#### North American Lithium

#### Mining

Ore mined of 351,100 wet metric tonnes (wmt) was 9% higher than the previous quarter due to higher mining activity in Phase 1 areas with low strip ratios. The commencement of mining in Phase 3 delivered unexpected gains in ore tonnes compared to the Ore Reserve block model. ROM feed grade delivered to the ROM stockpile at the plant averaged 1.23% Li<sub>2</sub>O for the quarter, which was higher than previous quarters due to higher grade ore mined around the historical underground mine workings. The Run of Mine (ROM) stockpile totalled 256,665 tonnes as at 31 March 2024, a 56% increase from 31 December 2023. The ROM stockpile has been increased to manage mine productivity fluctuations as mining activity progresses through the areas of historical underground mine workings. Completion of the Crushed Ore Dome also provides the ability to build crushed ore inventory between the crusher and the mill.




Figure 1: NAL mining areas

#### Production

The crushing circuit processed 260,528 tonnes of ore at an average feed grade of 1.24% Li<sub>2</sub>O, a 3% decrease in ore processed compared to the previous quarter. Improvements in feed grade offset lower ore processed due to challenges resulting from winter conditions and mechanical unplanned shutdowns.

Process plant utilisation declined during the quarter with an average mill utilisation of 73%, a decrease of 2% compared to the prior quarter. Mill utilisation was lower due to unplanned shutdowns caused by freezing in crushing buildings, frozen conveyor belts and heating issues. The ability to build crushed ore inventory between the crusher and mill from the new refeed system improved plant utilisation and ore processed tonnages, with plant utilisation averaging 78% in February and March post commissioning of the refeed system.

The Li<sub>2</sub>O recovery for the quarter was 67%, an increase of 5% compared to the prior quarter. Recoveries improved due to strong operational performance from metallurgical improvement and the positive impact of a retrofit high-density conditioning tank installed in the prior quarter. A historical record global process recovery of 69% was achieved in March 2024.

NAL produced 40,439 dry metric tonnes of spodumene concentrate at an average grade of 5.4% Li<sub>2</sub>O, an increase of 18% compared to the prior quarter. The rise in concentrate production was achieved by higher feed grade and higher recoveries, despite the negative impact of challenging winter conditions and unplanned shutdowns that reduced mill operating time and ore throughput.

In March 2024, NAL achieved a record monthly production of 15,699 dry metric tonnes, a 13% increase on the previous monthly production record observed in December 2023. NAL achieved multiple daily production records of spodumene concentrate in March between 710 – 750 dry metric tonnes per day.

#### Sales

NAL revenue was A\$58 million for the quarter, an increase of 152% compared to the prior quarter. The increase in revenue was driven by a 142% increase in concentrate tonnes sold by NAL in addition to a 6% increase in average realised selling price for the quarter.

Total concentrate sold during the quarter was 58,055 dry metric tonnes, an increase of 142% on the prior quarter. Four marine cargos departed port during the quarter, with three cargos sold to the international lithium market and one cargo sold to Piedmont Lithium. NAL also shipped concentrate from the port by rail which was sold to Piedmont Lithium. The increase in sales volume Quarter on Quarter resulted from the carryover of a 2023 shipment for Piedmont Lithium that departed port in January 2024. Average marine cargo shipment size for the quarter was approximately 14,000 dry metric tonnes of spodumene concentrate.

The average realised selling price (FOB) increased by 6% to A\$999/dmt (US\$657/dmt) compared to the previous quarter. NAL's average realised selling price for the quarter was negatively impacted by the weighting of cargos to spot market prices. Lithium price indices stabilised throughout the quarter, with NAL incurring Quotational Period adjustments totalling A\$4.5 million (A\$77/dmt) relating to a December 2023 Quarter shipment. The estimated underlying average realised selling price achieved for the quarter, excluding Quotational Period adjustments, was approximately A\$1,076/dmt (US\$706/dmt).

A total of 2,040 tonnes of spodumene concentrate was stockpiled at the port as at 31 March 2024.

#### Costs

Unit operating costs for NAL increased 10% Quarter on Quarter to A\$1,536/dmt (US\$1,008/dmt). Controllable costs increased due to seasonal pit dewatering activities as the NAL operations head into the Northern Hemisphere spring. Higher mine transport costs were incurred from the haulage of waste material over longer distances to available waste rock stockpiles. These higher waste rock transport costs are expected to persist into the 2025 fiscal year.

Unit operating costs benefitted from significantly higher concentrate sold during the quarter, however this was mostly offset by unfavourable inventory movements resulting from the sale of higher cost inventory built up over the first half of the 2024 fiscal year. The unfavourable inventory movements were a reversal of the favourable inventory movements observed in the prior quarter.







Figure 2: NAL Global Recovery and Mill Utilisation

# **Project Development**

# Québec, Canada

# North American Lithium

#### **Crushed Ore Dome**

The Crushed Ore Dome is designed to act as a secondary supply source of crushed ore to the mill to maintain process plant utilisation. The dome will have a storage capacity of around 6,000 tonnes of crushed ore when completed.

The concrete installation of the loading ramp was completed during the quarter, together with the installation of the dome fabric for the North and South walls. All mechanical installation had been completed by the end of March, with the exception of the retractable chute which will be installed in April. Installation of all cable trays is complete, and power cables have been pulled to all conveyors and junction boxes have been installed.

Pre-operation verification activities continued during the quarter, with a plant shutdown planned in April for final equipment installation. Post quarter end, the build of the crushed ore stockpile commenced inside the dome.

#### Jaw Crusher C-150

The Jaw Crusher C-150 project is designed to stabilise mill throughput by minimising blockages in the crushing circuit and minimising use of the rock hammer on the ROM pad. All C-150 componentry was received at site during the quarter, with the decision made to complete installation on the ROM pad. The C-150 jaw crusher will be installed following the completion of civil works next quarter.

#### Moblan Definitive Feasibility Study

The definitive feasibility study (DFS) for the development of a lithium mine and concentrator at Moblan was released during the quarter, confirming a post-tax net present value (NPV) of C\$2.2 billion for the project. The Moblan DFS was based on an annual production rate of 300ktpa spodumene concentrate over 21-year Life of Mine (LOM) via open pit mining at a rate of 1.8Mtpa.

#### Moblan Lithium Project Permitting

The environmental assessment process continued for the Moblan Lithium Project during the quarter. Activities on site included progression of base line environmental studies which will contribute to the Environmental and Social Impact Assessment (ESIA) that is underway. Once completed, the ESIA will be submitted to Québec authorities with the Cree Nation Government also involved in the approval process.

Applications for the use of land for the Moblan processing plant and mine waste storage facility have been submitted and approved by authorities, with a decree from the environmental authorities remaining outstanding. Federal authorisations are also required to be obtained for the anticipated impacts on watercourses in the immediate area.



#### **Authier Lithium Project Permitting**

The environmental assessment process continued for the Authier Lithium Project during the quarter. Key activities included continuation of studies on transport, air quality, water treatment and noise. Community and stakeholder consultations are planned for next quarter to discuss results from the studies which will form part of the Environmental and Social Impact Assessment (ESIA). Finalisation and submission of the impact assessment is targeted for the end of 2024, with BAPE (Bureau d'audiences publiques sur l'environnement) hearings possible in early 2025.

# **Exploration**

### Québec, Canada

#### North American Lithium

The 2024 exploration drilling program commenced at NAL during the quarter, with the program designed to confirm geological continuity and assess the potential for new discoveries outside the mining lease. The drilling program objectives include detailed assessments of the thickness and geometry necessary for the potential identification and conversion of mineral resources. At 31 March 2024, a total of 12 diamond drill holes measuring a total of 3,687 metres had been completed, with two drill rigs used throughout the quarter. The 25,000 metre drilling program is expected to be completed by the end of 2024.

#### Vallée Lithium Project

The 2023 Vallée Lithium Project drilling results were received during the quarter. They do not support progression to the Second Option of the earn-in and joint venture agreement. As such, NAL will retain its' current 25% interest in the Vallée Lithium Project Joint Venture and will evaluate other opportunities within the JV tenements as they are identified.

#### Western Australia, Australia

#### Tabba Tabba Project

The maiden exploration drilling completed at Tabba Tabba in December 2023 identified high potential pegmatite systems containing caesium and tantalum<sup>1</sup>. The 77-hole air core drilling program for 1,473m focused on two key areas, with results in the northern drill area identifying a zone of alteration, interpreted as the targeted southern extension to the Tabba Tabba mine stratigraphy. The southern drill area, sited around the Roadside and Turley prospects, intersected narrow pegmatite within broader zones of elevated tantalum and caesium geochemistry, typical of a LCT type pegmatite system.

An orientation ground gravity geophysical survey has been completed during April to identify the prospective gabbro – sediment contact for targeting, as this is an important control for lithium mineralisation within the area. The gravity survey covers a 7km x 2km area and comprises approximately 2,500 stations. Once completed, the gravity data will help target the pegmatite system and potential lithium rich zones at depth for Reverse Circulation (RC) testing.

#### **Mt Dove Project**

Planning for first drilling at Mt Dove continued during the quarter. The program will test magnetic features and structural targets beneath cover for bedrock gold anomalism of similar style to De Grey Mining's nearby Hemi discovery.

#### **Morella Lithium Joint Venture Project**

Sayona holds a 49% equity stake in the Morella Lithium Joint Venture, which comprises lithium rights to six tenements in the Pilbara covering 426 square kilometres and two tenements in South Murchison covering 48 square kilometres. Morella Corporation Limited (ASX: 1MC) is the manager of the joint venture.

During the quarter project data including geochemistry, geophysics and geological mapping continued to be reviewed with multiple targets being identified. At the Tabba Tabba East tenement a preliminary RC drill programme has been outlined with commencement planned during Q4 FY24.

At the Mt Edon project in the South Murchison a significant volume of pegmatites cut the greenstone stratigraphy. A RC drill programme has been outlined for 2024 to assess deep ground penetrating radar (DGPR) features, geochemical targets and mapped pegmatites.

# Corporate

#### **Non-Executive Director Appointment**

In February 2024, Mr Lucas Dow was appointed as a Non-Executive Director, effective 14 February 2024. Mr Dow is a highly experienced mining engineer, who has led resources organisations at the Chief Executive Officer level and held executive and non-executive director roles in both listed and unlisted entities. Mr Dow previously held the role of CEO, Bravus Mining & Resources, being critical to the successful commencement of the Carmichael mine and rail projects in Central Queensland.

#### **Appointment of Chair and CEO**

The search for a suitably qualified Chair and CEO continued during the quarter. Appointments for these key roles are dependent on identifying candidates with relevant skillsets for the respective positions. The Company will announce appointments for these positions following Board approval of recommendations from the Nomination and Remuneration Committee.

#### **Interim Financial Report**

Sayona released its Interim Financial Report for the half year ended 31 December 2023 on 14 March 2024. The Group recorded an underlying EBITDA of \$9.5 million for the half year (2023: \$20.4 million underlying EBITDA loss), and a consolidated loss after income tax of \$32.5 million over the same period (2023: \$18.7 million loss).

#### Cash Balance<sup>1</sup>

The balance of cash and cash equivalents at the end of the quarter was \$98.9 million, a \$59.1 million decrease over the equivalent balance of \$158.0 million at 31 December 2023.

Major cash inflows for the quarter included:

- net receipts from customers of \$29.5 million from the sale of spodumene concentrate, which included customer repayments of \$13.6 million for Quotational Period adjustments relating to a prior quarter shipment;
- proceeds of \$15.2 million from joint venture partners; and
- proceeds of \$2.1 million relating to interest income.

Major cash outflows for the quarter included:

- \$66.9 million on production expenditure;
- \$16.3 million on capital expenditure relating to the acquisition of plant and equipment at the Québec lithium projects;
- \$19.3 million on administration, corporate and payroll costs across all projects in Canada and Australia; and
- \$7.7 million on exploration and evaluation expenditure mainly relating to the Québec lithium projects.

During the quarter, the Company made payments of \$0.5 million to related parties, representing remuneration for Executive Directors and Non-Executive Directors.

#### Sayona Québec Joint Venture (SYQ) Cashflow

During the quarter, SYQ had receipts from customers of \$30 million and payments of operating costs of \$70 million, resulting in a net cash outflow from operating activities of \$40 million reflecting the continuing ramp-up of NAL operations. SYQ incurred lower quarterly capital expenditure of \$16 million and exploration expenditure of \$2 million, resulting in a net cash outflow from investing activities of \$18 million. Equity contributions from joint venture partners totalled \$61 million for the quarter. The net increase in cash and cash equivalents for the SYQ joint venture was \$3 million.

#### **Group Cashflow**

Outside of the SYQ joint venture, Sayona incurred payments of operating costs of \$13 million. Sayona (excluding SYQ) incurred capital expenditure of \$1 million and exploration expenditure of \$6 million, resulting in a net cash outflow from investing activities of \$7 million. Sayona made payments to the SYQ joint venture of \$46 million. Other net cash flows were an inflow of \$4 million. The net decrease in cash and cash equivalents for Sayona, excluding the SYQ joint venture, was \$62 million.




Figure 6: Sayona net cash flows for March 2024 Quarter
