

TRIGG BUILDS GOVERNMENT SUPPORT WITH PRESENTATION TO UTAH STATE NATURAL RESOURCES COMMITTEE

HIGHLIGHTS

- Trigg Minerals Managing Director Andre Booyzen has delivered a presentation on Trigg's Antimony Canyon Project (ACP) to the Utah State Natural Resources, Agriculture and Environment Interim Committee
- Trigg received the invitation to present from the Utah State Legislature following recent meetings with Utah State Senators and Utah Governor Spencer Cox
- Invitation marks Trigg's growing relationships with Utah's government bodies and the State's interest in its plans to develop ACP
- Key government officials and representatives have requested a site visit to ACP, which the company will be arranging very shortly
- Developing ACP can provide a secure US sovereign source of antimony but also provide economic and social benefits, including stable, long-term employment opportunities in Garfield County, which is a key priority
- Mr Booyzen is also meeting with Department of Energy senior officials and deputy secretary in Washington to discuss government funding for developing both the Tennessee Mountain Tungsten project in Nevada and Antimony Canyon project in Utah

Trigg Minerals Limited (ASX: TMG, OTCQB: TMGLF) is pleased to announce its Managing Director Andre Booyzen, has given a presentation on the Company's Antimony Canyon Project to the Utah State Natural Resources Committee, following an invitation by the Utah State Legislature.

The invitation marks Trigg's growing relationship with Utah Government bodies following several meetings with Utah State Senators and Representatives, and a meeting with Utah Governor Spencer Cox.

Trigg Minerals Managing Director Andre Booyzen commented:

"Utah is a Tier-1, mining-friendly jurisdiction. The legislators have a keen interest in the project, as it not only has the potential to provide the US with a secure sovereign source of antimony, but also to deliver economic and social benefits to Garfield County in southern Utah."

"In the words of Utah Representative and Committee Chair, Carl Albrecht, southern Utah's biggest export is its young people. Our project will employ locals and will welcome back the young people from Garfield County by providing stable, long-term employment. This is echoed by Antimony town locals who support the project not only for the economic benefits, but also for the opportunities it could provide for the younger generations of their families."



Mr Booyzen also has meetings planned with senior officials and the Deputy Secretary at the US Department of Energy in Washington DC, as the Company continues to educate and engage both federal and local politicians and officials on its plans for ACP. These efforts continue to garner strong support for the project.
