The VG1 portfolio returned -0.5% in April,  $^2$  with the long book contributing +0.3%, while the short book returned -0.8%.

April was a month in which markets were highly volatile, whipsawing around tariff announcements. The month started with a dramatic correction post "Liberation Day", with global equity markets reacting negatively to worse-than-feared tariff policy from the Trump Administration, compounded by hedge funds being forced to deleverage. This was followed by a dramatic reversal as a "90 day pause" on tariff implementation was confirmed. Amongst the macroeconomic and geopolitical volatility, US 1Q25 earnings were up 12% on the prior corresponding quarter according to Goldman Sachs, and significantly better than consensus forecasts.

The biggest positive contributor for VG1 in April was Toyota Industries (share price  $\pm 32\%$ ), which reportedly received a buyout proposal from Toyota Motor, according to Bloomberg. The thematic of Japanese authorities working to improve corporate governance practices, which includes encouraging companies to simplify or unwind their cross-holdings of subsidiaries, has been a key reason for our positive view on many stocks in Japan.

Our gold-exposed holdings were also strong contributors after gold rallied +5% during the month. We retain a bullish view on gold equities.

Key detractors were positions more heavily impacted by the China-US tariffs (such as GE HealthCare Technologies), as well as our technology and semiconductor holdings (Amazon, Meta and SK Hynix).

**Buy-back:** In April, approximately 2.3m VG1 shares were bought at an average price of \$1.47.
