## NATIVE TITLE AGREEMENT FOR TABBA TABBA MARKS A KEY STEP FOR DEVELOPMENT

### Highlights

- Australian lithium explorer and developer Wildcat Resources Limited (**Wildcat, ASX: WC8** or the Company) and the Nyamal native title holders have signed a Native Title Agreement over Wildcat's 100% owned Tabbatabba Project, in the Pilbara region of Western Australia
- The Nyamal native title holders are the Traditional Owners of the land on which the Tabbatabba Project is located and are represented by the Nyamal Aboriginal Corporation (**NAC**), a Registered Native Title Body Corporation
- The signing of this Native Title Agreement represents a significant milestone for NAC and Wildcat, signifying genuine collaboration and facilitates project development whilst both protecting cultural heritage and country
- The Native Title Agreement builds on the existing strong working relationship developed between NAC and Wildcat during the discovery phase as Wildcat looks towards the development and operating phases of the Tabbatabba Project

As part of the Native Title Agreement, Wildcat will commit to a broad range of actions including aboriginal heritage management protocols, cultural awareness training, social opportunities, employment and contracting opportunities, and compensation.

Execution of the Native Title Agreement is a significant milestone for the Company and NAC. It will facilitate the development of the Project and deliver many benefits to the Nyamal native title holders and surrounding communities.

With the Native Title Agreement now in place, the Company continues to fast-track the path to development with the continuation of the Project's Definitive Feasibility Study (DFS) while progressing exploration at its Bolt Cutter Central Project, 10km to the west of the Project, where Wildcat has discovered further spodumene-bearing pegmatites.

**Wildcat Chairman Jeff Elliott commented:** "We thank the Nyamal people for their continued support of the Project and successful negotiation of the Native Title Agreement. We look forward to continuing a close relationship with the Nyamal people, to unlock the benefits from this exciting new project in the Pilbara."

**NAC Co-Chair Troy Eaton commented:** "We are happy to have built a strong relationship with the Wildcat team during our negotiations for the Tabbatabba project. We look forward to the benefits this project can deliver to the Nyamal people and the local community, while showing respect to our country."

Mining + Heritage Legal have advised Wildcat and Agreement Hub and Houston Legal have advised NAC in relation to this transaction.
