**CORPORATE GOVERNANCE STATEMENT**

This Corporate Governance Statement is current as at 27 September 2017 and has been approved by the Board of the Company on that date.

This Corporate Governance Statement discloses the extent to which the Company as at the date follows the recommendations set by the ASX Corporate Governance Council in its publication Corporate Governance Principles and Recommendations (3rd Edition) (**Recommendations**). The Recommendations are not mandatory, however the Recommendations that will not be followed have been identified and reasons provided for not following them along with what (if any) alternative governance practices the Company intends to adopt in lieu of the recommendation.

The Company has adopted a Corporate Governance Plan which provides the written terms of reference for the Company's corporate governance duties.

**Due to the current size and nature of the existing Board and the magnitude of the Company's operations as a Listed Investment Company, a number of the recommendations below are difficult to adopt in full. Whilst the company does have an Audit & Risk Committee, the Board considers the Company will not gain any benefit from other individual Board committees and that its resources would be better utilised in other areas. The Board is of the strong view that the experience and skill set of the current Board is sufficient to perform these roles. Under the Company's Board Charter, the duties that would ordinarily be assigned to individual committees are currently carried out by the full Board under the written terms of reference for those committees.
