- ARR increase since 1<sup>st</sup> October = \$496,885 (+16%)

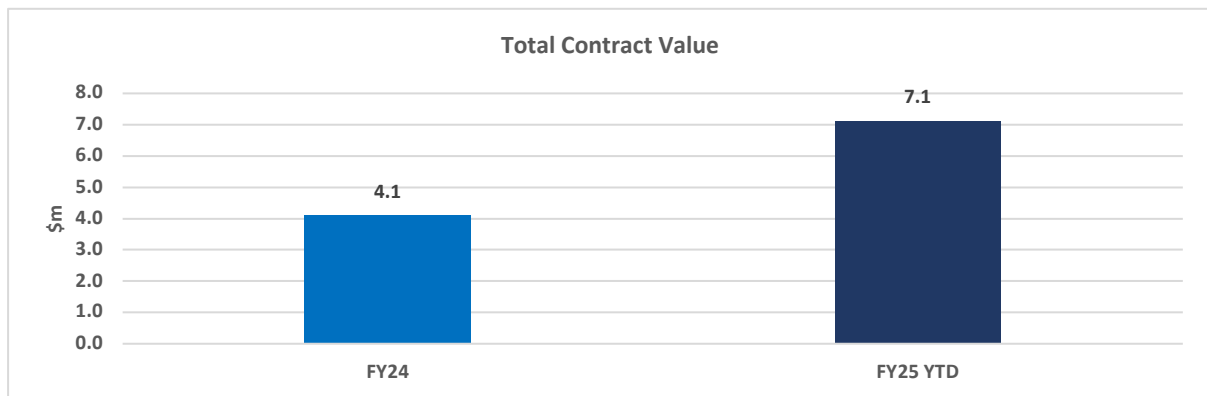
