# Financial Statements and Reports of the Directors and the Auditor in respect of the year ended 30 June 2016

To receive and consider the Annual Financial Report of the Company for the year ended 30 June 2016, together with the declaration of the Directors, the Directors' Reports, the Remuneration Report and the Auditor's Report.

**Note**: In accordance with the Corporations Act, the Company is not required to provide a hard copy of the Company's Annual Financial Report to shareholders unless a shareholder has specifically elected to receive a printed copy. # Resolution 1 – Re-election of a Director – Mr Greg Chessell

To consider and, if thought fit, to pass, with or without amendment, the following resolution as an **ordinary resolution**:

"That, for the purpose of clause 13.2 of the Constitution and for all other purposes, Mr Greg Chessell, a Director, retires by rotation, and being eligible, is re-elected as a Director."

#### Resolution 2 - Re-election of a Director - Mr Jay Hughes

To consider and, if thought fit, to pass, with or without amendment, the following resolution as an **ordinary resolution**:

"That, for the purpose of clause 13.2 of the Constitution and for all other purposes, Mr Jay Hughes, a Director, retires by rotation, and being eligible, is re-elected as a Director."

#### Resolution 3 - Election of a Director - Mr Anthony Brittain

To consider and, if thought fit, to pass, with or without amendment, the following resolution as an **ordinary resolution**:

"That, for the purpose of clause 13.4 of the Constitution and for all other purposes, Mr Anthony Brittain, a Director is re-elected as a Director."

# Resolution 4 - Adoption of Remuneration Report

To consider and, if thought fit, to pass, with or without amendment, the following resolution as a **non-binding resolution:** 

"That, for the purpose of Section 250R(2) of the Corporations Act and for all other purposes, approval is given for the adoption of the Remuneration Report as contained in the Directors' Report, for the financial year ended 30 June 2016."

Note: the vote on this Resolution is advisory only and does not bind the Directors or the Company.

#### **Voting Prohibition Statement:**

A vote on this Resolution must not be cast (in any capacity) by or on behalf of any of the following persons:

- (a) a member of the Key Management Personnel, details of whose remuneration are included in the Remuneration Report; or
- (b) a Closely Related Party of such a member.

However, a person (the voter) described above may vote on this Resolution as a proxy if the vote is not cast on behalf of a person described above and either:

- (a) the voter is appointed as a proxy by writing that specifies how the proxy is to vote on this Resolution; or
- (b) the voter is the Chair and the appointment of the Chair as proxy:
  - i. does not specify the way the proxy is to vote on this Resolution; and
  - ii. expressly authorises the Chair to exercise the proxy even though this Resolution is connected directly or indirectly with the remuneration of a member of the Key Management Personnel.

#### **Explanatory Statement**

# Resolution 1 - Re-election of a Director - Mr Greg Chessell

Clause 13.2 of the Constitution requires, at each Annual General Meeting, one third (or the nearest one third) of Directors must retire, provided that no Director shall hold office for a period in excess of 3 years. This excludes the Managing Director, an Alternate Director, or any Directors required to retire, or vacates office under other clauses of the Constitution. A Director who retires by rotation under Clause 13.2 of the Constitution is eligible for re-election. Mr Chessell retires by rotation and seeks re-election.

Mr Chessell is the Head of Research at Euroz Securities Limited and the Senior Resources Analyst. He spent 10 years working as a geologist in WA prior to entering the stockbroking industry in 1995. Mr Chessell is an Executive Director of Euroz Limited and Euroz Securities Limited. Mr Chessell holds a Bachelor of Applied Science in Geology from the University of Technology, Sydney (UTS) and a Graduate Diploma in Business from Curtin University. Mr Chessell is a member of the Audit & Risk Committee.

## Resolution 2 - Re-election of a Director - Mr Jay Hughes

Clause 13.2 of the Constitution requires, at each Annual General Meeting, one third (or the nearest one third) of Directors must retire, provided that no Director shall hold office for a period in excess of 3 years. This excludes the Managing Director, an Alternate Director, or any Directors required to retire, or vacates office under other clauses of the Constitution. A Director who retires by rotation under Clause 13.2 of the Constitution is eligible for re-election. Mr Hughes retires by rotation and seeks re-election.

Mr Hughes has worked in stockbroking since 1986. He is Executive Chairman of Westoz Investment Company Limited and Ozgrowth Limited, an Executive Director of Westoz Funds Management Pty Ltd, Euroz Securities Limited and Prodigy Investment Partners Limited. Mr Hughes holds a Graduate Diploma in Applied Finance and Investment from the Financial Services Institute of Australasia (FINSIA). In December 2000 Mr Hughes was recognised as an affiliate of the ASX. In May 2004 he was admitted as a Practitioner Member (Master Stockbroking) of the Stockbrokers Association of Australia (SAA).

# Resolution 3 – Election of a Director – Mr Anthony Brittain

Clause 13.4 of the Constitution provides that a Director can be appointed as an additional Director but that the Director only holds office until the next annual general meeting where they are eligible for re-election.

Mr Brittain is the Chief Operating and Financial Officer and an Executive Director of Euroz Limited, Euroz Securities Limited, Entrust Private Wealth Management Pty Ltd, Prodigy Investment Partners Limited, Flinders Investment Partners Pty Ltd and Dalton Street Capital Pty Ltd.

Prior to joining Euroz, Mr Brittain spent 7 years at a WA stockbroker and 7 years in London and Singapore with a UK fund manager. Mr Brittain holds a Bachelor of Commerce from the University of Western Australia (UWA), is a member of the Institute of Chartered Accountants (CA), holds a Graduate Diploma in Applied Finance and Investment from the Financial Services Institute of Australasia (FINSIA), is a Graduate of the Australian Institute of Company Directors and is a member (Master Stockbroking) of the Stockbrokers Association of Australia (SAA).

## Resolution 4 - Remuneration Report

#### General

The Corporations Act requires that at a listed company's Annual General Meeting, a resolution that the Remuneration Report be adopted must be put to the shareholders. However, such a resolution is advisory only and does not bind the Directors or the Company.

The Remuneration Report sets out the Company's remuneration arrangements for the Directors and Key Management Personnel of the Company. The Remuneration Report is part of the Directors' Report contained in the Annual Financial Report of the Company for the financial year ended 30 June 2016.

Under changes to the Corporations Act which came into effect on 1 July 2011, if at least 25% of the votes cast on Resolution 3 are voted against adoption of the Remuneration Report at the Annual General Meeting, and then again at the Company's 2016 Annual General Meeting, the Company will be required to put to Shareholders a resolution proposing the calling of a general meeting to consider the appointment of Directors of the Company (**Spill Resolution**).

If more than 50% of shareholders vote in favour of the Spill Resolution, the Company must convene the general meeting (**Spill Meeting**) within 90 days of the Company's 2016 Annual General Meeting. All of the Directors who were in office when the Company's 2016 Directors' Report was approved, other than the Managing Director of the Company, will cease to hold office immediately before the end of the Spill Meeting but may stand for re-election at the Spill Meeting. Following the Spill Meeting those persons whose election or re-election as Directors is approved will be the Directors of the Company.

At the Company's previous annual general meeting the votes cast against the remuneration report considered at that annual general meeting were less than 25%. Accordingly, the Spill Resolution is not relevant for this Annual General Meeting.

A reasonable opportunity will be provided for discussion of the remuneration report at the Annual General Meeting.

- Undirected proxies granted to these persons will not be voted and will not be counted in calculating the required majority if a poll is called on this Resolution.
- The Proxy Form notes it is the Chair's intention to vote all undirected proxies in favour of all Resolutions.

# **Definitions**

**Key Management Personnel** has the same meaning as in the accounting standards and broadly includes those persons having authority and responsibility for planning, directing and controlling the activities of the Company, or if the Company is part of a consolidated entity, of the consolidated entity, directly or indirectly, including any director (whether executive or otherwise) of the Company, or if the Company is part of a consolidated entity, of an entity within the consolidated group.

#### Closely Related Party of a member of the Key Management Personnel means:

- (a) a spouse or child of the member;
- (b) a child of the member's spouse;
- (c) a dependent of the member or the member's spouse;
- (d) anyone else who is one of the member's family and may be expected to influence the member, or be influenced by the member, in the member's dealing with the entity;
- (e) a company the member controls; or
- (f) a person prescribed by the Corporations Regulations 2001 (Cth).

**Remuneration Report** means the remuneration report set out in the Directors' Report section of the Company's Annual Financial Report for the year ended 30 June 2016.

# **General Business**

To transact any other business which may lawfully be brought before the meeting in accordance with the Company's constitution.

# Instructions for Completing 'Appointment of Proxy' Form

- 1. (Appointing a Proxy): A member entitled to attend and vote at an Annual General Meeting is entitled to appoint not more than two proxies to attend and vote on a poll on their behalf. The appointment of a second proxy must be done on a separate copy of the Proxy Form. Where more than one proxy is appointed, such proxy must be allocated a proportion of the member's voting rights. If a member appoints two proxies and the appointment does not specify this proportion, each proxy may exercise half the votes. A duly appointed proxy need not be a member of the Company.
- 2. (**Direction to Vote**): A member may direct a proxy how to vote by marking one of the boxes opposite each item of business. Where a box is not marked, the proxy may vote as they choose. Where more than one box is marked on an item the vote will be invalid on that item.
- 3. (Signing Instructions):
  - (Individual): Where the holding is in one name, the member must sign.
  - (**Joint Holding**): Where the holding is in more than one name, all of the members should sign.
  - (**Power of Attorney**): If you have not already provided the Power of Attorney with the registry, please attach a certified photocopy of the Power of Attorney to this form when you return it.
  - (Companies): Where the company has a sole director who is also the sole Company Secretary, that person must sign. Where the company (pursuant to Section 204A of the Corporations Act) does not have a Company Secretary, a sole director can also sign alone. Otherwise, a director jointly with either another director or a Company Secretary must sign. Please sign in the appropriate place to indicate the office held.
- 4. (Attending the Meeting): Completion of a Proxy Form will not prevent individual members from attending the Annual General Meeting in person if they wish. Where a member completes and lodges a valid proxy form and attends the Annual General Meeting in person, then the proxy's authority to speak and vote for that member is suspended while the member is present at the Annual General Meeting.

All your securities will be voted in accordance with your directions.

## **Appointment of Proxy**

Voting 100% of your holding: Direct your proxy how to vote by marking one of the boxes opposite each item of business. If you do not mark a box your proxy may vote or abstain as they choose (to the extent permitted by law). If you mark more than one box on an item your vote will be invalid on that item.

Voting a portion of your holding: Indicate a portion of your voting rights by inserting the percentage or number of securities you wish to vote in the For, Against or Abstain box or boxes. The sum of the votes cast must not exceed your voting entitlement or

Appointing a second proxy: You are entitled to appoint up to two proxies to attend the meeting and vote on a poll. If you appoint two proxies you must specify the percentage of votes or number of securities for each proxy, otherwise each proxy may exercise half of the votes. When appointing a second proxy write both names and the percentage of votes or number of securities for each in Step 1 overleaf.

A proxy need not be a securityholder of the Company.
