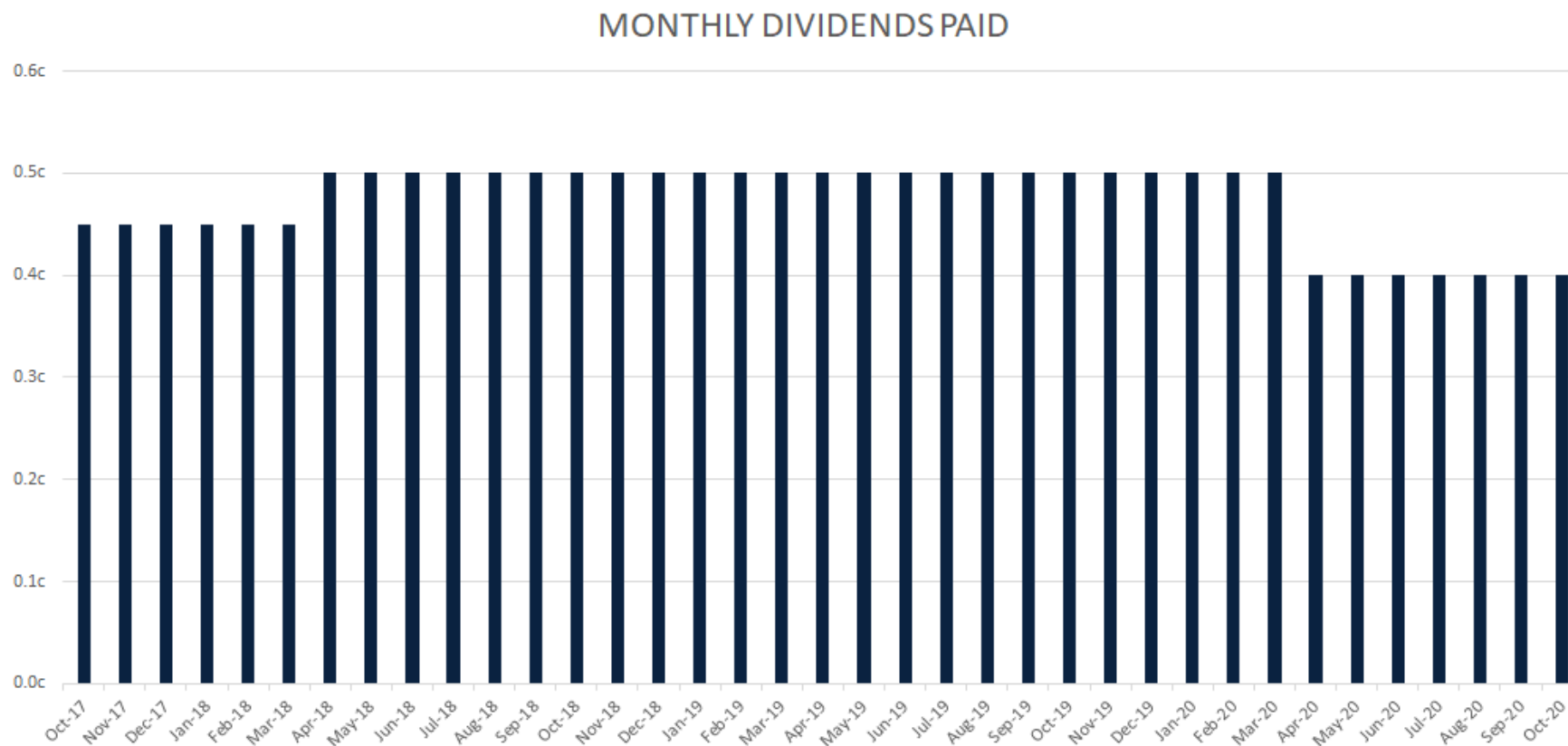

MONTHLY DIVIDENDS

The Directors are pleased that, with effect from October 2017, the Company has been able to achieve its stated aim to declare and pay monthly dividends.

In addition to the consistent monthly dividends, a 3 cent per share special dividend was paid in May 2019.

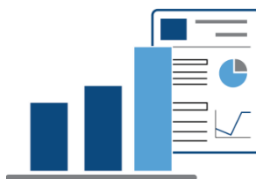
